Michael Sastre To Return for Our February Meeting

“So, abstract painting is basically just another way of interpreting or expressing ideas, ... What is interesting, I think, is that all painting use the same basic elements — colour, shape, texture — to achieve their desired intention. The difference is that representational painting involve shapes that we are familiar with, while abstract paintings need not. Nevertheless, with the right emphasis and interaction of colours and shapes, abstract paintings can be just as exciting and emotional as any other. Why must a painting represent something?”

In the beginning of our January workshop, Michael Sastre asked the participants, "What is abstract art and how does looking at abstract art make you feel?" Mr. Sastre emphasized finding the balance between painting pure form, resulting in abstract art, versus painting pure content, resulting in highly representational art. He noted that the balance between form and content is

ambiguous and has slid closer on the scale towards content, as opposed to pure form since the inception of early 20th century abstract art. Mr. Sastre explained that all paintings have an abstract base in their pure form. As more content and refinement is added and the painting is developed, then the painting will cross the line to representational. As one knowledgeable participant observed, "All art is abstract."

PRESIDENT'S MESSAGE

As I write this message the snow is falling thickly onto the ground and I am wondering when Montgomery County Schools will be closing. This time of year, you can never totally count on planned events as these weather systems come and go. So far we have been lucky for MCAA events. We started off the new year on the very first weekend in January with the Abstract Workshop. For the member meeting on Wednesday the 13th we have a bit of a follow-up critique planned. Our instructor, Michael Sastre has offered to return and critique the completion of our art works started that day. Of course, if you didn't attend the workshop you are more than welcome to bring another painting for critique. That Saturday, we had a very enjoyable afternoon with Mike as he covered the abstract movement and provided example of many abstract painters' works. We were encouraged to think about our opinion of abstraction and challenged to identify a famous painting that he himself abstracted. This method of looking at art work can be very useful in the preparation process of our own paintings. To observe the basic areas of light, dark and in between, we can achieve a balance of form and content for our artwork. The hands-on exercise entailed taking a chosen print or photo and reducing it to the basic abstract forms. Pictures with concentrations of color in a couple of areas were the best to work with and everyone came up with interesting interpretations of their chosen piece. The process proved to be a bit more challenging than some of us anticipated and provided the opportunity for deep analysis and discernment of value patterns and gradations of color.

At our member meeting in January Laura-Leigh Palmer presented an interesting and informative demonstration on website development. Some of the stumbling blocks to creating websites were covered as well as website development software programs that are available. Here are some notes provided by our membership chair Sandy Cepatis:

- Σ● One program to use to do your own: Dreamweaver
- Σ● Reasonable cost to set up a website \$800-\$1200
- Σ● Take a class at Montgomery College...workforce development
- Σ● Get a domain name in your name (web address)
- Σ● Buy closet space online (Dovad.net)

Montgomery County Financial News

I'm afraid the 6% sales tax will have a bad effect on sales of our art work. With the inflation and wages remaining level, everybody will be feeling the squeeze.

There were a lot of tax increases passed during O'Malley's Special Session. They were listed in the *Gazette* and in *The Washington Times*. Here is the list:

- Income Tax now has three new brackets: 5% for single filers who make more than \$150,000 and joint filers who make more than \$200,000.
- 5.25% for singles making more than \$300,000 and joint filers making more than \$350,000.
- 5.5% for singles and joint filers making more than \$500,000
- Personal Exemptions would be increased by \$800 for single taxpayers making less than \$100,000 per year and joint filers making less

than \$150,000 a year in federal adjusted gross income.

- Sales tax increased to 6%.
- Tobacco Tax: Increased from \$1 to \$2 a pack.
- Vehicle Titling Tax increased from 5% to 6% with full trade-in allowances.
- Corporate Income taxes were increased from 7% to 8.15% along with other restrictions.

Budget cuts were made in Education, \$77 million transferred from the employee Health Insurance Fund to cover operating costs and 500 vacant state jobs eliminated. The utility property-tax grant was eliminated to save \$31 million. In spite of all this, \$262 million still need to be cut from the State budget.

According to a story in *The Washington Times* this past week, the governor has INCREASED the state budget.

The Plaza Art team in Rockville has their winter class schedule out and available in their store or online. While most of their January classes are full, there are still openings for February and March. Plaza is offering unique classes not only in art techniques but also in marketing your art. In addition, the Rockville store hosts national artist workshops on designated weekends. Break away and try something new that will reenergize your artistic vision.

With so many changes in the art market over the last several years, there seems to be a class or workshop for everyone.
